3) Matters arising from the minutes

c) VDS Statement was brought forward. Mandy Boon reported that Uttlesford District Council were being co-operative, but they need more pictures. 75 draft copies to be printed for public approval before it is adopted by the community and then by UDC. The final document will be 17 pages long and 200 copies will be printed. The conservation officer has made no comments and RCCE has been most helpful. The group intends to call a meeting in December to look at the draft and hope that UDC will approve it in the New Year.

The Chairman thanked Mandy and commented that the PC looks forward to seeing the completed document.

a) Hawkspur Green road signs - these are in the pipe line. Oxen End signs completed

b) Footpath Map-Cllr Wren produced a draft copy.

Comments made: i) add the path alongside the river

ii) mark bridleways slightly differently

iii) include with the VDS and get it printed by UDC..

Bulb planting - after discussion the Council resolved to ask Cllr Wren to purchase 300 bulbs of different varieties. Crocuses & snowdrops round the Village Sign, under the noticeboards at Hawkspur Green & Oxen End. Wild Daffodils by the Church Sign and on the bank between Wainsford Farm & Gridiron Villas. This would be a trial & it was hoped to involve some of the youngsters in the village

d) Styles road repairs was deferred to the next meeting.

The Chairman thanked Jim Andrews for his work to the Car Park and private path

e) <u>Litter Bins</u>- 2 No have been removed from telegraph poles due to complaints from local residents

Dog Litter Bins have been placed at the side of the Sewage Works, the Church Car Park and near the Noticeboard at Hawkspur Green.

- **4) County Councillors report** Cllr Simon Walsh reported on Post Office Closures (views to be made known by November 16, 2007). The Fire Authority. Widening of M11 at Junction 8. Local Government finance up 2%. County Council to keep costs down. These reports in full will be attached to the minutes.
- 5. Highways the Clerk attended a meeting of the East Area Panel in Dunmow. A new Area Highways Manager, David Forkin, has been appointed and expressed most strongly his disappointment in the way that the West Area Office has dealt with all the communications from the Parish Council over the last 2 years. The Clerk listed all the repairs that the Council had raised with the department and was asked to put them in writing. This was done. The Planned Parish Visit (scheduled for July) will now take place in the New Year.

There were no objections to the front picket fence. The application for a footpath to the side of The Chapel has not yet been resolved.
