Local partnership highlighted in list of national digital leaders

The Essex + Herts Digital Innovation Zone (DIZ), a cross-border, cross-sector partnership to promote digital services across west Essex and eastern Hertfordshire, has been selected as one of the country's top 100 Digital Leaders, in the Cross-Sector Digital Collaboration of the Year category.

The final placings and category winners will now be decided by a public vote which runs until 14 August. Anybody can vote and the winners will be announced in October.

The DIZ is made up partners representing local government, health, education, community and voluntary service and the private sector, and covers the districts of Broxbourne, East Herts, Epping Forest, Harlow and Uttlesford.

Activities for young people
